Job Summary

The Underwriter evaluates the risks of PE Partners' municipality members within the state of Tennessee. Responsibilities include management of multi-leveled exposure accounts while meeting underwriting objectives. Utilizes established underwriting guidelines, procedures, and premium / pricing goals within a designated authority level. Determines adequate and fair premium charges for members based on exposure information, loss control efforts, and individual member situations.

- Process new and renewal business with review of exposures and identification of hazards through the applications, review of loss control surveys, experience and schedule rating, and other pricing mechanisms, within assigned authority.

- Support the collective efforts of colleagues in Member Services and Risk Control to enhance member relationships.

- Provide general administrative assistance to management as required.
